

RACKS ON BUSES. CBAG'S BIG OPPORTUNITY CAME IN THE EARLY 2000S WHEN IT LOBBIED FOR A PROVISION FOR BICYCLE/PEDESTRIAN TRAFFIC ON THE PROPOSED RAVENEL BRIDGE. THE GROUP'S LOBBYING EFFORTS ATTRACTED WIDE SUPPORT FROM HIGH-PROFILE INDIVIDUALS AND INSTITUTIONS, AND THE FINAL BRIDGE PLAN INCLUDED A 12-FOOT BICYCLE AND PEDESTRIAN PATH. IN 2005, CBAG CHANGED ITS NAME TO CHARLESTON MOVES, IN RECOGNITION OF A BROADER MISSION: TO PROMOTE ALTERNATIVE MODES OF TRANSPORTATION SUCH AS CYCLING, WALKING AND MASS TRANSIT. IN 2009, CHARLESTON MOVES LAUNCHED BATTERY2BEACH, A 32-MILE ROUTE OF MIXED-USE PATHS CONNECTING THREE MAJOR BEACHES IN THE CHARLESTON AREA. WITH SOLID FINANCES AND DEDICATED OFFICE SPACE, CHARLESTON MOVES HIRED ITS FIRST PAID FULL-TIME DIRECTOR IN 2014.

CHARLESTON MOVES' CORE MESSAGE IS THAT EVERYONE - INCLUDING THE DRIVING PUBLIC - BENEFITS WHEN PEOPLE WALK, RIDE BIKES OR TAKE TRANSIT. SINCE ITS FOUNDING IN 2005, KEY SUCCESSES INCLUDE THE BIKE/PEDESTRIAN LANE OVER THE ARTHUR RAVENEL JR. BRIDGE AND LANES ALONG EAST BAY STREET ON THE PENINSULA AND ON COLEMAN BOULEVARD IN MT. PLEASANT. CHARLESTON MOVES HELPED INITIATE THE LOWLINE PROJECT, A MULTI-MILE PLANNED BIKE AND PEDESTRIAN PATH THAT FOLLOWS ABANDONED RAIL TRACKS THROUGH THE UPPER PENINSULA. EVEN BROADER GAINS HAVE BEEN MADE IN CHANGING THE PUBLIC CONVERSATION. IN RECENT YEARS, NO TRANSPORTATION PROJECT IS DISCUSSED WITHOUT ATTENTION TO ALTERNATIVE FORMS OF TRANSPORTATION, AND CHARLESTON MOVES HAS A SEAT AT THE TABLE WHENEVER THESE PROJECTS ARISE.
