

where school children, folks in wheelchairs, and people with canes cross streets safely in their own time. We see streets lined with homes, bustling shops and restaurants. We see bridges and waterways where people on bicycles and on foot travel alongside buses and cars on their way to work, to the doctor, to the grocery store - freely and safely.

For the 2021 year, 82 cents of every dollar spent went to our charitable programs.

**What We Are Doing:**

**Bridges Front-and-Center**

Bridges are now front-and-center to serve as connectors instead of barriers. We have continued to coordinate with the City of Charleston on an ad hoc basis as they work through permitting the new Ashley River Bicycle & Pedestrian Bridge, including regular check-ins to develop improvements to the West Ashley Greenway, which will feed into the new bridge.

Collaborating with our coalition and Charleston County, we provided input and continued data collection for a Better North Bridge, including several surveying and bike/ped count sessions. With the consultants proposing three route alternatives, the year ended with the first public input session and the start of the public input period. We rallied attendance and began

planning our complementary outreach. We hosted a critical mass bike ride over the North Bridge, with at least 250 participants, demonstrating the need for safe access and the broad public support for change.

Obtaining input from relevant agencies, we began crafting a technical assistance grant application to the National Park Service for conceptual planning around the Wappoo Cut Bridge. We also hosted a critical mass bike ride over the Cut, with at least 150 participants, demonstrating early support for addressing bike/ped access over the Wappoo Creek.

We continued to provide input on the planned bicycle and pedestrian bridge adjacent to the Limehouse Bridge over the Stono River, as well as the proposed multiuse path for all I-526 river crossings. And we coordinated with SCDOT and local jurisdictions to improve the Isle of Palms Connector, which now has buffered bike/ped lanes with green visibility paint on each side of the bridge, connecting to the Town of Mount Pleasant's multi-use paths. The improvements to the Connector are examples of the first buffered bike lanes in the Charleston region, and the second time green paint has been incorporated.

### Complete Streets

We mobilized and advocated for robust multi-modal space and design in key projects, including shifting project scopes to include intersection improvements. Our engagement led to improved designs, additional funding and/or leveraged opportunities.

We have worked with the City of Charleston and SCDOT for years to improve Brigade Street. The goal has been to make it complete, with the most robust infrastructure design possible. Brigade serves as a pilot project to show what SCDOT will allow, facilitating an evolution of what is considered the "standard" baseline infrastructure for our state. In 2021, the final installation was completed, including the City's first-ever protected bike lane, as well as one of the first examples of the use of green paint in bike/ped design in our region.

After participating in SCDOT's safety review of King Street, from Line to Huger Streets, we helped advocate for County funding for the necessary study of the recommendations from the review report. That funding was approved. Additionally, we began coordinating with the City of Charleston to improve their design proposal for Huger Street, from Meeting Street to Morrison Drive. Our suggestions of wider bike lanes with green paint, improvements marked through the intersections, addressing on-street parking, and narrowing the lanes of traffic have been incorporated into the new design.

As part of our interagency discussions on the North Bridge, it became apparent that improving Azalea Drive would not only benefit current vulnerable road users, but also become an important connection to the future Better North Bridge project. The City of North Charleston, Charleston County, BCDCOG, SCDOT and Charleston Moves realized that Azalea Drive from Cosgrove to Leeds could likely benefit from a road diet, which would also provide the opportunity for bike lanes and intersection improvements. Charleston County funded a study to determine whether a road

diet was feasible, with the results being favorable. The County hosted public feedback sessions, with the vast majority of input being positive. Charleston Moves assisted with outreach, and SCDOT restriped half the roadway during 2021, and will work on the second half in 2022. The agency leveraged a planned resurfacing to make the project cost-effective.

Mount Pleasant Way, a planned town-wide bicycle and pedestrian system, is coming along nicely. Charleston Moves has formally supported the Town's requests for right-of-way acquisition for specific segments through the Charleston County Greenbelt program, and several of those requests have been selected for funding.

Charleston Moves worked with citizen advocates, as well as state and local leadership, to begin getting the necessary funding for a multiuse path along Sanders Road in West Ashley, connecting to the new schools and library. We coordinated with neighbors to collect bike/ped counts to help inform the need for better infrastructure. With one segment funded by the County, we are advocating for individual developers to complete the path.

Charleston Moves also worked with citizen advocates for the successful funding of the first portion of a sidewalk on Fleming Road, as well as a pedestrian crossing and sidewalk at the municipal golf course, all on James Island.

### Policy Updates

In 2021, SCDOT officially approved an agency-wide Complete Streets Policy,

and updated their design manual and engineering directives, to emphasize greater analysis and consideration for all modes. Charleston Moves provided several recommendations and information for inclusion in these policies and planning guides, most of which were incorporated into the documents.

Charleston Moves staff has also been serving on SCDOT's newly-created statewide Complete Streets Council, and participating in sessions on SCDOT's draft Safety Action Plan for vulnerable road users across the state.

Charleston Moves provides strong leadership and resources for several proposed projects and plans throughout the county, ensuring people who ride bikes, walk and take public transit are represented throughout the planning, designing and funding processes. - Daniel Island: City of Charleston's bike/ped bridge proposals
- Regional: Lowcountry Corridor public comment periods, the City of Charleston's comprehensive plan process, individual redevelopment projects, state 3-foot passing bill, Mark Clark Extension comment period.

We also returned to our annual Mobility Month program, with an impressive number of virtual participants. May's Mobility Month events are aimed at bringing the community together to elevate multi-modal accomplishments, provide updates on our priority projects, and offer calls to action, as well as volunteer opportunities, to advance our people-powered movement. Critical mass is of critical importance as we work to build widespread, diverse community support and demonstrate how safe, equitable infrastructure that works for all, benefits all.

#### Our History

In 1993, the Charleston Bicycle Advocacy Group (CBAG) was founded to elevate support for bicyclists in and around Charleston. The group
