Bridges Front-and-Center

Bridges should serve as connectors instead of barriers. For the new Ashley River Bicycle & Pedestrian Bridge, we have continued to watchdog the project, the construction of which is moving quickly with the western approach platform in place, and pile work continuing in the river.

Collaborating with our coalition and Charleston County, we assisted with the County's fourth federal grant application to USDOT for a Better North Bridge. Our work included many hours of community outreach and engagement, compiling letters of support, and research for the grant application, encouraged the County to vote in favor of applying, and participated in the grant debriefing with federal staff. We coordinated public comment in support of SCDOT's addition of the North Bridge to their State Bridge Program, as well as a resolution from the Berkeley-Charleston-Dorchester Council of Governments' Charleston Area Transportation Study (CHATS) Policy Committee requesting an upgrade of the North Bridge crossing, preferably with a replacement, to prioritize access for people walking and bicycling over the river.

We continued to watchdog bike/ped access in the Main Road Segment A project that includes the Limehouse Bridge. We engaged with SCDOT and City of Charleston on options to retrofit the James Island Connector and Wappoo Cut Bridge. We coordinated letters of support to SCDOT's addition of the Ben Sawyer Bridge to their State Bridge Program. We participated in ribbon-cutting events for: North Charleston's Cosgrove Avenue Extension protected multi-use path, connecting Spruill Avenue and the old Navy Base redevelopment; North Charleston's Palmetto Commerce Interchange protected multi-use path connecting neighborhoods across I-26; Mount Pleasant's Coleman Boulevard bike lanes, with green paint at conflict points, across the Shem Creek Bridge.

Complete Streets

We mobilized and advocated for robust multi-modal space and design in key projects, and our engagement led to improved designs, additional funding and/or leveraged opportunities.

We participated in SCDOT's Road Safety Audit for Ladson Road, and continued engaging the public and SCDOT on their Folly Road Safety Audit. We celebrated SCDOT's groundbreaking for the Ashley Phosphate Road Safety Audit construction.

Charleston Moves has formally supported Mount Pleasant Way, a planned town-wide bicycle and pedestrian system. We have engaged in a safety workshop for a redesign of Whipple Road, encouraged public input during comment sessions, and encouraged participation in community meetings, including projects that are part of the Town's Safety Action Plan.

We have continued to coordinate with agencies around improved designs for the redevelopment of Union Pier's street network, the Lowline, Meeting Street Road, Hagood Avenue, King Street, Morrison Drive, Rivers Avenue, Spruill Avenue, Riverland Drive, Folly Road, Harborview Road, various pathways in the City of Folly Beach, Long Point Road, River Road, Maybank Highway, Albemarle Road, Sam Rittenberg Boulevard, and Old Towne Road.

Policy Updates

We successfully encouraged the Town of Mount Pleasant to compromise on their bicycle/e-bike ordinance so that cyclists can still access bike lanes and pathways in a safe and reasonable manner. Working with our partners, we presented a Transportation Sales Tax proposal to Charleston County that reasonably accommodated investment in a countywide bicycle and pedestrian plan, as well as important public transit updates.

We coordinated with and supported the Berkeley-Charleston-Dorchester Council of Governments (BCDCOG) Safety Action Planning process, the City of North Charleston's Safety Action Planning application, and three Safety Action Plan infrastructure grant applications from the City of Charleston, the City of Folly Beach, and the Town of Mount Pleasant.

We submitted a support letter to the Federal Transit Administration (FTA) for the region's Lowcountry Rapid Transit (LCRT) project.

We submitted comments to SCDOT for their Momentum 2050 statewide transportation plan.

Leadership

Charleston Moves provides strong leadership and resources for several proposed projects and plans throughout the county, ensuring people who ride bikes, walk and take public transit are represented throughout the planning, designing and funding processes. In addition to what is listed in specific aforementioned projects, we participate on the

We hosted our annual Mobility Month program, with an impressive number of participants. May's Mobility Month events are aimed at bringing the community together to elevate multi-modal accomplishments, provide updates on our priority projects, and offer calls to action, as well as volunteer opportunities, to advance our people-powered movement. Critical mass is of critical importance as we work to build widespread, diverse community support and demonstrate how safe, equitable infrastructure that works for all, benefits all. We tied our events to our 20th anniversary celebration, as well as advocacy around the Ashley River Bridge, downtown street improvements, and our safety data collection activities. Mobility Month 2025 had 430 event participants, the distribution of 50 free bike light sets and "ride safe" educational cards, almost 23 hours donated by volunteers, 20 collaborating partner organizations, and 14 mobility initiatives elevated in the community. We also hosted our annual gala, Pedal & Panache, elevating our movement through action and a celebration of progress.

Our History

In 1993, the Charleston Bicycle Advocacy Group (CBAG) was founded to elevate support for bicyclists in and around Charleston. The group campaigned for and successfully achieved bicycle lanes on Coleman Boulevard in Mount Pleasant, for bicycle racks on buses, and for improved cycling access to the Isle of Palms. CBAG served on the regional transportation board, voting for sidewalk improvements (especially near schools) and miles of bike paths near county parks.

In the early 2000s, CBAG's lobbying efforts for bike and pedestrian access on the newly-proposed Ravenel Bridge met fierce opposition from the South Carolina Department of Transportation, but it also attracted wide support from high-profile individuals and institutions. Building a groundswell of support, the final bridge plan included a 12-foot wide bicycle and pedestrian path. It also helped shift the focus for CBAG, which changed its name to Charleston Moves in 2005, in recognition of a broader mission: to promote active modes of transportation such as biking and walking, and accessing the bus.

In 2009, Charleston Moves launched the Battery2Beach Route initiative, working with multiple government agencies on a vision of 32 miles of continuous bike and pedestrian lanes connecting major beaches in the Charleston area with the iconic Battery at the foot of the Charleston peninsula. At least 40% of the route is complete, with more segments in the works.

Charleston Moves continues to expand the notion of what transportation is, what it should be and what it can be by working with local municipalities, agencies and other organizations that share its vision of a community connected by mobility options. With a staff of two, Charleston Moves fights for the public's right to safe streets, paths and bridges.

If the Governance Committee determines that there is a conflict of interest, it shall refer the matter to the Board of Directors. The board may seek information from the director, officer or key person with the conflict prior to beginning deliberation and reaching a decision on the matter. However, a conflicted person shall not be present during the discussion or vote on the matter.
